


MUNICIPAL SWIMMING POOL INTERNAL RULES SUMMER 2024



Article 1

The dates and times when the municipal swimming pool is open to the public are posted at the pool entrance.

Closure in case of storm or fog.

Pools must be evacuated 20 minutes before closing time.

Article 2

The public is admitted to the bath after paying the admission fee according to the tariff displayed at the cash desk. Prices are set each year by the municipal council. Under penalty of fines, entry to the pool and its annexes is strictly forbidden outside opening hours.

Article 3

Access to the establishment will be refused to:

- Any person in state of drunkenness or abnormal agitation
- Bathers with wounds, dressing or skin conditions
- Children under eight years of age unaccompanied by a person over 18 years of age (proof of identity (ID) may be requested at the entrance by the staff on duty, as well as the lifeguard)
- Any person whose behavior might disturb the peace and quiet of the facility
- No animals will be allowed in the facility, not even on a leash around the pools

Article 4

All bathers are required to use the cabins on arrival and departure.

Bathers are only admitted to the pools barefoot and in a state of absolute cleanliness. To this end, use of showers and foot baths is compulsory (except for thoses using overshoes).

Access to the beaches will be strictly prohibited to people dressed other than in swimwear, with a tolerance for the wearing of sleeveless t-shirt to protect themselves from the sun, except accompanying children under 8 years and people with disabilities.

Article 5

The pools are under the constant supervision of the lifeguard.

The lifeguard is responsible for the smooth running of the facility and the general discipline of users.

To this end, he/she may take any necessary measures against offenders, including warnings, expulsion without refund of entry fees, etc.

In the event of poor behavior, access to the facility may be denied after a warning has gone unheeded.

In the event of a major problem, the lifeguard is autorized to open one or more cabins in the presence of an adult witness.

If necessary, the reception staff or lifeguard may call in the police or gendarmerie.

Article 6

It is strictly forbidden:

- Swimming in shorts, briefs, underpants, thongs and topless, but only in a bathing suit.
- Children under 2 (two) years of age (or older if not potty-trained) are not allowed in the pools without a « special bathing » diaper.

- Running on the beach or playing violent games.
- Forcing or pushing others into the water.
- Play ball on the beach or in the pools without the autorization of the lifeguard.
- Use glass underwater masks.
- To use floating equipment (mattresses, inner tubes) without the autorization of the lifeguard.
- Eating in the pool area.
- Bring dangerous objects or objects unrelated to pool activités.
- Smoking, vaping or the use of electronic cigarettes.
- Throw papers or garbage anywhere other than in the garbage cans provided.
- Take photographs without the permission of the lifeguard or other interested parties.
- Generally speaking, to soil the beaches or pools, or to engage in acts or games that may be detrimental to the peace and safety of users, or to public decency.
- Article 7 Snacks will be tolerated on the beaches provided they are away from the pools.
- Article 8
 Inexperienced swimmers must not use the large pool.

 Dynamic and static freediving are prohibited.

 The paddling pool is reserved for young children, to persons with disabilities.

 Any children must be accompagned or watched by an adult.
- Article 9 All groups admitted are under the full responsability of their instructors.

 Instructors will leave their contact details in a notebook at the cash desk.

 The responsability of the lifeguard cannot be held responsible for these groups, with the exception of water safety.

In view of this responsability for the general safety of users, the lifeguard may prohibit, without appeal, any action that he or she deems to be dangerous, whether for a bather belonging to a supervised group or for an independent user.

- Instructors must:
- Present themselves in sufficient numbers to comply with current regulations.
- Show the lifeguard their diploma or supervisory approval.
- Provide a list of bathers.
- Sort ou swimmers and non-swimmers in the main pool.
- Identify non-swimmers with a special cap or armband.
- Groups will use the communal changing rooms and their clothing will be the responsability of their instructors.

All groups must abide by their own rules and regulations.

- Article 10 The toboggan is used as follows and in turn:
 - 1 person in the tube
 - 1 person waiting at the top of the access platform
- Article 11 The municipal administration declines all responsability for accidents resulting from failure to comply with these rules
- Article 12 All staff at the Mens municipal swiming pool are required to ensure strict compliance with the present regulations.
