1/ How to equip yourself

Wearing appropriate clothing for the activity is MANDATORY.

If you don't own riding gear, please wear at least long, loose-fitting pants and closed-toe shoes. **Please note:** no shorts, skirts, or dresses : ankles and calves must be protected.

>> Helmets with hairnets are available for loan.

* **For summer courses**, bring the following items in your backpack: a snack, a bottle of water, sunscreen, a hat/cap, and a cardigan/sweater.

2/ How to get to the Ranch

We are located in the « Bois d'Arbin ». At the first bend on the Mottaret road (after the tunnel):

- Public sign for "equestrian center"
- Turn right onto the bridge
- Public parking 200m away.



⚠ Use Google Maps to locate us, the GPS point is in the right place, but be careful with the I-phone GPS which sends you to the head office and not to the Ranch !

* **Free Méribus shuttle access :** « **l'Armoise** » **bus stop** (line D Mottaret) in front of the fire station and the Alpina local, then approximately 10 minutes on foot ([On foot from l'Armoise bus stop](#)) ; or **from La Chaudanne** (Olympic Park) about 15-20 minutes on foot going up to the edge of the slope ([On foot from Chaudanne](#)).

3/ Schedule and organization of the internship

Horseback riding is a unique sport because it involves a living animal, which requires care and attention before and after each session.

That's why the time spent preparing and caring for the pony/horse is an essential part of the activity! This includes: catching the pony, grooming, tacking up... and after the ride, untacking and taking care of the animal again.

These moments help build a bond between the child and the pony and are just as valuable as the time spent in the saddle.

Riding times are adapted to the age and attention span of the children, to ensure a positive, safe, and enjoyable experience for all.

So the camp is not just about “riding a pony” — it’s about living a complete equestrian experience, at the child’s pace... and the pony’s too!

For Equi-Discovery and Equi-Adventure Camps:

The time listed on your booking includes the preparation time.

- > About 30 minutes are dedicated to grooming and tacking up.
- > Followed by 45 minutes to 1 hour of riding for *Equi-Discovery*,
- > And 1h15 to 1h30 of riding for *Equi-Adventure*.

For Equi-Sport camps:

This camp is designed for riders capable of independently managing their horse's preparation and care.

Morning:

- > 8:15 a.m.: Meet at the paddock to pick up the horses and ride them bareback to the Ranch (remember to wear a helmet).
- > Independent preparation of the horse.
- > 9:00 a.m. to 11:00 a.m.: Riding session.
- > Then: unprepare, care, and return to the paddock independently.

Afternoon:

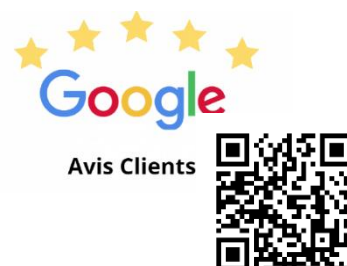
- > 4:00 p.m.: Meet to pick up the horses from the paddock and prepare them.
- > 4:30 p.m. to 5:30 p.m.: Riding session.
- > Then unprepare, care, and return to the paddock bareback.

Lunch break:

You can bring a picnic for your child. Tables are available on site, but we do not provide supervision during the lunch break. The course can therefore be done for a full day if your child is sufficiently independent.

GENERAL SALES TERMS



Registration for one of our activities implies the acceptance of the general terms and conditions of sale and the Nordic Ranch's internal regulations.

RESERVATION AND PAYMENT :

Our activities are by reservation: the day before at the latest for rides and activities that require a lot of logistics; 3 hours in advance maximum for shorter activities (reindeer visits and mini-farms per exemple).

All activities must be paid in full at registration.

The prices indicated are firm.

Payment at the office by check, cash or credit card. Or payment via online booking.

For any activity booking made at the office, and if the customer does not have an accepted means of payment, they will be invited to go online to book their activity and pay directly online. Registration for the activity will only be valid once it has been paid in full. The same applies to any booking made by phone or email.

TERMS OF CANCELATION AND MEETING :

- Cancellation before 15 days: full refund (less management fees);
- Between 15 and 3 days: 50% refunded (minus management fees);
- At 3 days or less: 100% of the total amount of the reservation will be due

A meeting time and place are systematically communicated to you regardless of the service.

For the smooth running of the activities and out of respect for the other participants and the professional who supervises you, be sure to anticipate your travel in order to be punctual.

Any delay of more than 10 minutes harms the smooth running of our activities on the day. Beyond this deadline, the instructors leave for activities and no refund or compensation from us is possible.

If the client does not show up on the date and time of the reservation, does not notify, is unreachable on the telephone number provided, no refund or compensation from us is possible.

In the event of a delay or abandonment on your part during the activity, no refund from us is possible.

In the event that you wish to postpone your activity, due to weather that would inconvenience you (or any other reason), a supplement of 50% of the price of the activity will be charged to you, as compensation for occupying a slot that could have been sold to other customers.

Le Ranch Nordique reserves the right to cancel an activity due to special conditions (conditions that do not ensure the safety of participants and/or horses, force majeure, etc.). In this case, you will have the option of either choosing a new date or a refund of the activity (less the management fees for online bookings).

INSURANCE, RESPONSIBILITIES, LICENSE :

The Ranch Nordique is insured for civil liability.

However, riders must have their own insurance for the practice of horse riding. Please note: many insurances do not cover accidents related to riding.

It is therefore strongly advised to take out a license from the French Equestrian Federation. This license can be issued with the Ranch Nordique.

The cost of the federal license is €36 for adults and €25 for children under 18.

If you do not wish to take out a license for your child during the courses, please provide us with a copy of an insurance certificate covering the risks associated with the practice of horse riding.

The practice of outdoor activities takes place in a specific environment called "at risk".

Each participant is aware, given the specific nature of the activities offered, that he or she may run certain risks due in particular to the specific nature of the environment. He or she assumes them with full knowledge of the facts and must comply with the rules of prudence and follow the advice given by professionals.

Registration for one of our activities therefore implies acceptance of the risks inherent in the practice of horse riding and its related activities.

In the event of a personal accident, the liability of the Ranch Nordique and the instructor involved is released as soon as the victim is taken care of by the competent emergency services, and any hospital follow-up will be the responsibility of the accident victim's personal insurance.

The participant is responsible for the equipment lent to him or her for the activity. The professional cannot be held responsible for any damage that may be caused by the equipment made available.

In the event of theft or damage to the loaned equipment, the participant/customer may be asked for compensation for wear and tear or a full refund of the equipment.

Le Ranch Nordique cannot be held responsible for the loss, theft (including in vehicles) or breakage of objects (e.g. glasses, cameras, etc.) that participants may take with them during the activity and that may occur during the activity.

CONDITIONS FOR ACCESSING ACTIVITIES:

Access to the activities requires that the payment for it has been fully paid.

Our activities are open to all; however, depending on the activities, certain conditions must be taken into account (age limit, technical level, physical condition, etc.).

You must not have a medical contraindication to the practice of the chosen activity.

The Ranch Nordique is not responsible in the event that the client indicates when booking a level (equestrian or ski) that is not real. The Ranch reserves the right, if it finds a level insufficient to ensure safety, to refuse access to the activity without the possibility of reimbursement. As far as possible, the client will be offered another slot corresponding to the level adapted to him.

For certain activities, weight limits are set to ensure animal welfare and safety. These limits are clearly specified when booking. Thus, the Ranch reserves the right to refuse access to the activity without the possibility of reimbursement if this limit is not respected.

Wearing appropriate clothing for the activity is MANDATORY. Equip yourself with long, flexible trousers and closed shoes. Please note: no shorts, skirts or dresses; the ankles and calves must be protected.

The Ranch reserves the right to refuse access to the activity without the possibility of reimbursement if the outfit of the participants does not ensure their safety (for example: ski helmet mandatory for skijoring).

Riding helmets with a caps can be provided by the Ranch.

The instructors reserve the right to exclude a participant whose behavior is likely to disrupt the smooth running of the activity or compromise the safety of the group. In this case, the participant will not be able to claim any refund or compensation.

PERSONAL INVOLVEMENT WITH ANIMALS:

Horse riding is a sport that is practiced with live animals! This therefore requires arriving early to take care of your pony/horse (preparation time included in the activities), and leaving after taking care of it as well!

No act of mistreatment towards our animals will be tolerated. If the participant's actions are deemed disrespectful towards the animals, the participant will be excluded from the activity, without possible negotiation, and will not be able to claim any refund or compensation.

Internal Rules and Regulations

Article 1: Scope and Acceptance of the Rules

These Internal Rules aim to define the rules for proper functioning within the establishment named: Le Ranch Nordique.

They apply to everyone present on the premises, including:

- Riders,
- Horse owners with horses boarded at the facility,
- Accompanying persons, visitors, and spectators.

By registering at the establishment, each rider agrees to abide by these internal rules. Likewise, all visitors, including casual riders and accompanying persons, accept these rules by their presence at the facility.

TITLE I – GENERAL PROVISIONS

Article 2 – Authority and Safety

All individuals present at the facility must follow the safety instructions set by the management and supervisory staff.

Only the instructor is authorized to intervene during lessons. Parents, clients, or visitors may not interfere in lessons unless the instructor deems it necessary (e.g., pony rides for young children).

Article 3 – Behavior



Everyone at the facility—riders, owners, visitors—must show courtesy and respect toward staff, other riders and visitors, and especially toward the animals.

Article 4 – Prohibitions

The following are strictly prohibited within the facility:

- Smoking anywhere on the premises, indoors or outdoors, or playing with fire;
- Shouting;
- Feeding the animals without permission;
- Taking out ponies, horses, or other animals without a responsible person present;
- Playing in the hay or straw;
- Playing with any equipment (tractor, utility vehicles, quad bikes, wheelbarrows, fire extinguishers, water taps, tack, etc.);
- Playing ball games or engaging in any behavior that might frighten animals (e.g., running near them);
- Entering the arena during lessons for any reason;
- Moving or using jumps or obstacles without instructor permission.

Dogs are strictly prohibited inside the facility and in outdoor areas where equines are present. They are only tolerated nearby if kept on a leash.

 **Any brutality towards horses, ponies, or other animals is strictly forbidden.** 

No lessons may be given by any coach, friend, or outsider within the stables without prior and express permission from the equestrian center's manager, who may apply conditions, including fees.

Article 5 – Parking / Circulation Within the Facility

Only walking is permitted on the premises.

No vehicles are allowed in the stables, except for equine professionals (farriers, vets, equine dentists, etc.).

Vehicles, including bicycles and mopeds, must be parked in designated areas without blocking access for emergency or safety vehicles.

The equestrian center is not responsible for theft or damage to vehicles parked in designated areas.

Article 6 – Minors

Minors must be supervised by their parents, who must keep them away from horses and equipment, and prevent noisy behavior.

Article 7 – Access to the Stables and Equestrian Facilities

Silence is mandatory in the spectator areas of riding arenas.

Technical rooms and the use of bedding, feed, and hay storage areas are strictly off-limits to the public.

It is also forbidden to be near the facility's vehicles (tractor, truck, horse trailers, etc.).

Article 8 – Proper Conduct

Silence is customary around the riding arena. Instructors may ask disruptive individuals to leave the viewing area.

To avoid trampling grass and creating mud, do not let your horse graze or walk near the arena.

All equipment made available to the public must be treated with respect.

Keep the premises clean—bins are available. The clubhouse and restrooms must be kept tidy (scrape off your boots, avoid putting feet on furniture or walls, wash used dishes, gather your belongings, etc.).

Anyone entering the property must comply with all posted prohibitions.

After using the arena or indoor school, all equipment must be put away, and manure must be collected and placed in the wheelbarrow provided near the arena.

TITLE II – RULES SPECIFIC TO RIDERS

Article 9 – Attire

Proper and suitable attire for horse riding is required at all times. This attire must conform to traditional equestrian standards.

Riders must wear a helmet at all times, both indoors and outdoors. Helmets must meet safety standards (NF EN1384).

The equestrian center assumes no responsibility in the event of non-compliance with this rule. The instructor is responsible for ensuring compliance.

For cross-country training, both a cross-country helmet and back protector are mandatory.

The French Equestrian Federation (FFE) recommends back protectors for minors during jumping, cross-country, and trail rides.

All riders must take care of the equipment and horses entrusted to them.

Article 10 – Insurance / Liability

In accordance with Articles L321-1 and L321-4 of the French Sports Code, participants are covered by the center’s liability insurance during equestrian activities. Riders should consult the office to understand the scope and limits of this coverage.

Any accident occurring while using obstacles or equipment without an instructor present is entirely the rider's responsibility, both in terms of liability and any resulting injuries or damages

All regular riders must hold an FFE (French Equestrian Federation) license, which provides liability insurance and personal accident coverage under displayed terms.

No rider may participate in club activities without paying the license fee, except for trail rides and hacks for non-regular clients (a 30-day green license is available).

For "pony-lead" rides, children are under the full responsibility of their parents or legal guardians. Any damage to personal items is the sole responsibility of the accompanying adult.

Instructions for pony-lead rides (route, safety tips, etc.) are posted.

Article 11 – Use of Facilities, Horses, and Safety Rules

Only employees, riders scheduled for lessons, or specially authorized individuals may enter stalls or handle horses, ponies, or other animals.

Each rider must ensure the cleanliness of the facility by picking up manure and waste after cleaning hooves or handling horses—whether in front of stalls, at the wash area, in the aisles, arena, or elsewhere.

Article 12 – Young Riders

The equestrian center is only responsible for minor riders during the scheduled activity time, including 15 minutes before and after the session (for preparation and return to the stable).

Outside of these times, minors are under the responsibility of their parents or legal guardians.

Article 13 – Theft at the Facility

Storage areas provided for riders are not monitored.

No special insurance covers these areas; personal items and equipment are stored at the owner's own risk.

Article 15 – Payment for Services

Riders should arrive at least 15 minutes before their lesson, which will start on time.

Activities must be paid for before participation.

No rider may take part in activities without having paid.

Cancellations must be made at least 3 days in advance, or the session will still be charged, according to our T&Cs.

TITLE IV – MISCELLANEOUS PROVISIONS

Article 19 – Opening Hours

Opening hours are posted at the office and must be respected.

Access outside of posted hours is only permitted with prior approval from the facility manager.

Article 20 – Fees

Rates are available at the office or online at: www.ranchnordique-meribel.com

Article 22 – Complaints

Any well-founded and justified complaints regarding the facility’s operations should be addressed to the manager either in person (by appointment) or in writing.

Article 23 – Sanctions

Sanctions, ranging from temporary suspension to permanent exclusion without refund of membership or registration fees, may be applied to anyone who fails to comply with these rules 15 days after formal notice is given without response.

Riders may be denied registration renewal due to failure to follow the internal rules.

This also applies to horse owners whose boarding contracts may be terminated.

Article 24 – Amendments

These internal rules may be amended or supplemented by the manager, with approval from the Mairie des Allues, particularly when new activities are introduced.

These rules are intended to prevent accidents, fires, and misunderstandings that may disrupt the atmosphere and proper functioning of the stables.
