

Preamble

In view of the general local authority code, in particular articles L. 2211-1 and following and article L. 2122-21,

In view of the temporary occupancy agreement for the public river domain n° 21922310267 concluded between the city of Meaux and VNF for the river stop of Meaux and the docking of the boat Spicy,

In view of the repeal of the decree n° 18-2470 from 26/07/2018,

Considering that the river stop is owned and run by the city of Meaux,

Considering that it is at the disposal of sailors from April 1st to October 31st,

Considering that it is necessary to implement rules to the functioning of the river stop of Meaux,

Considering that sailors are invited to read the following rules of procedure and to comply strictly with these conditions during their stopover at the river stop of Meaux,

TITLE I – TERMS OF ACCESS

Article 1.1

The boats frequenting the river stop must at all times be in compliance with French authorities, maritime rules, river rules, customs duty and other. They must also meet the requirements for navigability and safety regulations.

Article 1.2

The speed limit on the Marne is set at 12km/h and at 4 km/h near the river stop.

Article 1.3

Boats with a length exceeding 19 meters are not allowed to moor the pontoons.

Article 1.4

Access to the pontoons is forbidden to non-users.

Article 1.5

The users of the river stop must under no circumstances change the port facilities available to them.

Article 1.6

The gateway access is strictly restricted to users. The pontoons must always remain free and clear of any equipment. Dogs running on gateways and pontoons must be kept on a lead.

TITLE II - FINANCIAL CONDITIONS

Article 2

Docking is charged, same as the access to fluids. Users are to pay at the payment terminal with a credit card.

If the payment terminal is not working properly, it is advised to call Meaux Marne Ourcq Tourisme (open from tuesday to sunday from 10h to 12h30 and from 14h to 18h).

Each boat must display the docking ticket so it is visible from the exterior of the boat in case of a control.

The rates decided by the Mayor n° 2023-723 on 31 July 2023 are the following:

Docking (24h): 3€ / Water 80 liters (10min): 0.50€, Water 160 liters (20min): 1€, Water 240 liters (40min): 1.50€, Water 480 liters (1h): 3€ / Electricity 8h: 1€, Electricity 16h: 2€, Electricity 24h: 3€.

TITLE III - REGULATORY CONDITIONS

Article 3.1

Boats can dock for a maximum period of 5 days.

Article 3.2

The boats allowed to park must be registered and in possession of a valid navigation certificate.

Article 3.3

Boats in poor condition or unmaintained are not allowed to park at the river stop.

Article 3.4

Users are obliged to live together in harmony with visitors, walkers, fishers or other public frequenting the site.

Article 3.5

In case of a crowd at the river mooring, the mooring with other pleasure boaters is authorized, subject to prior agreement. Under no circumstances can the City of Meaux Meaux

RULES OF PROCEDURE

Article 3.6

Any breach can lead to the expulsion of the offender, with recourse to law enforcement forces if necessary.

Article 3.7

The agents of the river stop are entitled to execute, in case of need, any maneuver deemed necessary at the exclusive expense of the owner and without the responsibility of the latter being released.

Article 3.8

It is prohibited :

to light a fire on the pontoons

to wash cars, animals and any other object on the pontoons of the river stop

to wash the boats with the potable water of the terminal

to throw earth, rubble, rubbish, liquids or any other substance on the quay or in the Marne

to set up a camp, even temporarily

to pour waste water into the river

to use a generating set

to alter without permission the power stations and water stations that are set up on the pontoons

to carry out work on the boats that causes nuisance

to swim in the Marne in the surrounding area of the river stop

to practise water sports in the water of the river stop. Exceptions can be granted for occasional events.

Article 3.9

The boats must not hold any dangerous or explosive material aboard. In case of a fire on the mooring or in a nearby urban area, every boat must take the measures of precaution which are prescribed by the agents of the river stop. In case of a fire on a boat, the owner or the crew must immediately inform the fire brigade of Meaux: +33 (0)1.60.24.74.00 (or 18 or 112).

Article 3.10

Household refuse and waste of any kind must be put in the containers erected for this purpose, which can be found at quai Sadi Car-not.

Article 3.11

Heating apparatuses, lighting and electrical wiring must be conform to common standard. This applies also to any element connected with the technical installations named above and the supply terminals at the river stop.

Article 3.12

In case of any trouble or damage on the boat caused by a third party, the pleasure boaters are strongly advised to inform the local police (Community Police): +33 (0)1.60.24.35.35 or national police.

Article 3.13

If one or more of the elements that are part of the floating installations are out of order and cannot be used or if they are removed for repairs or other reasons, the City of Meaux will inform the users by setting up an appropriate sign.

Article 3.14
